11. Resolutions / General Amendments To League Rules

a) Proposed by the Committee - Amendment to Rule 2

Omit 'In the event that the league be wound up, after the settlement of all debtors, any monies or assets remaining shall be donated to the governing body of amateur snooker which as at the date of this document is the English Association of Snooker and Billiards (known also as the EASB).'

Add 'In the event that the league be wound up, after the settlement of all debtors and disposal of assets, any monies remaining shall be split equally between the registered members of the league. Qualifying members will be those who are fully paid up and have been registered continuously for the last 3 completed seasons prior to the date that the league be wound up.'

12. 2109/20 Season

a) Team and Player Registration Forms

The Three Player Division will be dropping from 14 to 12 teams due to Newport Wanderers and Saffron Flukiers dropping out.

The Four Player Division will be the same as last season with 7 teams.

b) Fixtures / Handicaps

The league fixtures are to be compiled, the handicaps are all ready for the season start and new players will be monitored by the Handicaps Sub-Committee, please come forward to the Committee if you think a handicap needs to assessed.

13. AOB

Dan Lewis discussed in the meeting regarding the change in World Snooker rules that will be coming in from the 29 August 2019, he would like representatives from Clubs/Teams to attend a seminar hosted by himself to update those on the rule changes.
